Please click on the button in the email to download the Annual Report. Hard copies are available. Stop by the pick-up box outside of the church office or call the church office for other options.

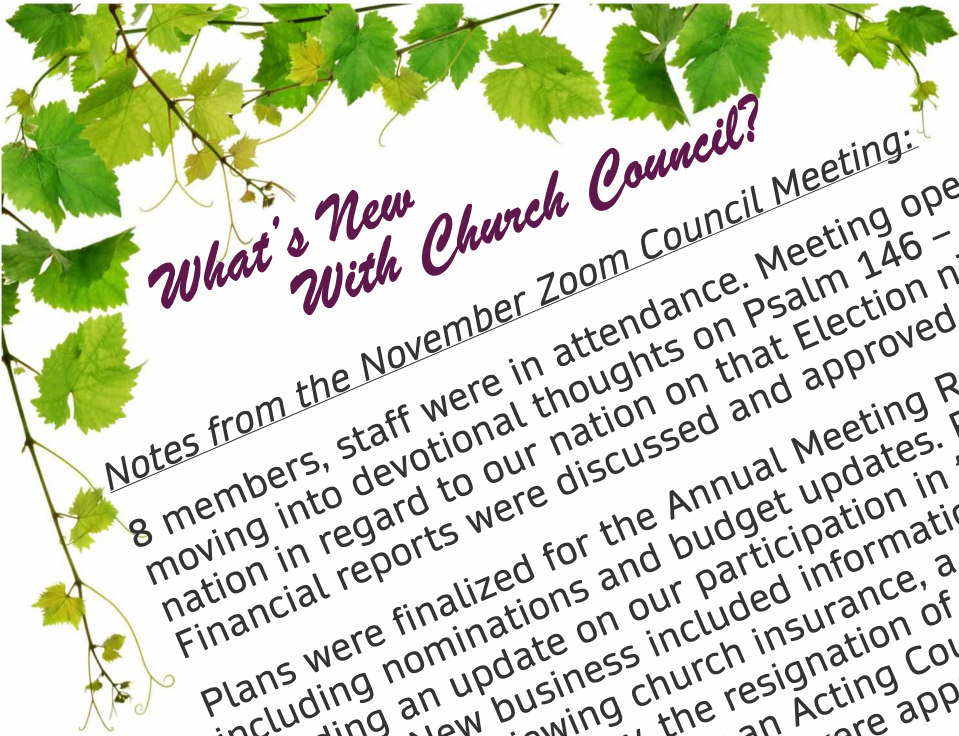

 8 members, staff were in attendance. Meeting opened with prayer moving into devotional thoughts on Psalm 146 – specifically for our nation in regard to our nation on that Election night. Minutes and Financial reports were discussed and approved.

Plans were finalized for the Annual Meeting Report and Meeting, including nominations and budget updates.
